The Trade is hereby informed that Board has decided to intensify the efforts to liquidate all pending IGST refund claims by observing a Special Drive "IGST/ITC Exports Refund fortnight" beginning from 15th March to 29th March 2018.

2. Accordingly, CGST & Central Excise (Jaipur Zone), Jaipur is observing "Exports Refund fortnight" beginning from 15th March to 29th March 2018 across all the field formations of the Zone wherein exclusive camps/ refund cells will be set up to deal with the cases of pending export related refund claims as well as to help Exporter Community so that common errors committed by the exporters while filing Shipping Bills and various returns are avoided *ab initio*. During this period special efforts will be made by the jurisdictional CGST Ranges/Divisions/ Commissionerates to deal with all the pending export related refund claims and to ensure timely sanction/disbursal of the same.

3. Further, in cases where deficiency memo have been issued by Divisional Officers, the concerned Exporters are requested to submit the desired information as early as possible so as to help in processing and sanctioning refund claims expeditiously.

4. All the Trade and Industry Associations/Chambers of Commerce are requested to give wide publicity and bring the contents of this Trade Notice to the notice of all their members to make this "Exports Refund Fortnight" a grand success.

5. The jurisdictional Commissioners are also requested to give wide publicity to this Special Drive and inform all the stake holders / Exporters under their respective jurisdiction about the contents of the above Trade Notice.
